

Alberta Pulse Growers Commission - Advisor Nominations 2020-21

The Alberta Pulse Growers Commission is seeking pulse growers to serve as Advisors in the 5 Zones. Each Zone has a maximum of 8 elected Advisors. Each Advisor term is 3-years and producers can remain engaged as an Advisor if successfully elected for up to 3, 3-year terms.

For 2020-21, there are Advisor opportunities in each Zone ([click here for the APG Zone Map](#)).

- Zone 1 – Two (2) Advisor Positions
- Zone 2 – One (1) Advisor Position
- Zone 3 – Six (6) Advisor Positions
- Zone 4 – Five (5) Advisor Positions
- Zone 5 – Two (2) Advisor Positions

Who is eligible? In each Zone, Farmers who have sold pulse crops in Alberta paying service charges to Alberta Pulse Growers since August 1, 2018. Eligible producers can be individuals or represent a corporation, partnership or organization.

Where do I send the nomination? Nominations must be filled in writing, or sent electronically, to the Alberta Pulse Growers Office at #101, 4721-47 Avenue, Leduc, AB, T9E 7J4 or by email to office@albertapulse.com by no later than November 1, 2020 at 4:00 PM.

2020-21 Advisor Nomination Form**

Nominations are open for advisors in the five Alberta Pulse Growers Zones. The term of office is 3 years.

Nominations for the position of Advisor must be:

- **Filed at the Alberta Pulse Growers Commission office at #101, 4721-47 Avenue, Leduc, AB, T9E 7J4 in writing on or by email at office@albertapulse.com on or before November 1, 2020 at 4:00 PM.**
- **Accompanied by consent of the eligible producer nominated.**

Eligible Producer: To be eligible to be an Advisor, nominate or vote the person must be an eligible producer in the zone in which the election is being held. An eligible producer means any producer who has grown and sold pulse crops in Alberta since August 1, 2018.

Identification of Eligible Producers to Region: Alberta Pulse Growers Commission can only identify location of eligible producer by mailing addresses. The 5 Zones are identified by municipal districts.

An Eligible Producer other than an Individual: An eligible producer may be an individual, a corporation, partnership or an organization other than a corporation or partnership. If an eligible producer is not an individual, then the corporation etc. may appoint a representative to act on its behalf as an eligible producer, including voting in an election and standing for office.

An individual cannot be a representative for more than one eligible producer (i.e. one vote) if an eligible producer is:

- a. A corporation, it shall appoint an individual who is a director, shareholder, member, officer or employee of the corporation as its representative
- b. A partnership, it shall appoint an individual who is a partner or employee of the partnership as its representative.
- c. An organization other than a corporation or partnership, it shall appoint an individual who is a member, officer or employee of the organization as its representative.

Alberta Pulse Growers Commission must be notified in writing by an eligible producer (being a corporation, partnership, or other organization) as to the appointment of its representative for that representative to be eligible to vote in an election, stand for nomination or hold office.

Elections: In the event of an election, it will be held on the selected day of the specific Zone Annual Meeting and participation to vote will be based on the registered producers attending the meeting. Secure electronic voting will be employed to address the election of Advisors.
